

## TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER History

The Texas Tech University School of Medicine was created by the 61st Texas Legislature in May, 1969 as a multi-campus institution with Lubbock as the administrative center, and with regional campuses at Amarillo, El Paso, and Odessa. In 1979, the charter was expanded to become the Texas Tech University Health Sciences Center (TTUHSC), leading the way for establishment of the School of Nursing, School of Health Professions, and the Graduate School of Biomedical Sciences. In 1993, the legislature authorized the establishment of a School of Pharmacy to be located in Amarillo. In addition, Health Professions programs were expanded to Amarillo and the Permian Basin. In 2003, the legislature authorized the establishment of a four-year medical school in El Paso, and in 2011, the Gayle Greve Hunt School of Nursing was established, also located in El Paso. Texas Tech University Health Sciences Center at El Paso (TTUHSC at El Paso) was established in May 2013 by the 83rd Texas Legislature as the fourth and newest university in the Texas Tech University System (TTUS). TTUHSC's schools are committed to regionalized, multi-campus educational experiences, and to the related biomedical research, graduate studies, patient care and community service required of a health sciences center. A primary effort is made to achieve a balanced group of students with qualified minority students, diverse age groups, and heterogeneous backgrounds in educational and life experiences.

TTUHSC has as its major objectives the provision of quality education and development of academic, research, patient care, and community service programs to meet the health care needs of West Texas, which in total is comprised of 108 counties and represents 50% of Texas' land mass and 9.4% of its total population. This 131,000 square mile service area and population of 3.1 million has been, and remains highly underserved by health professionals and accessible health care facilities, despite the substantial and meaningful contribution made by our institution. Demographic shifts in West Texas populations, as well as socioeconomic and epidemiologic characteristics of its sub-groups, create major and specific demands for service. While education of students and residents remains the primary focus of the institution, there has been an important impact on the health status of West Texas. The lack of a single locus of population density has resulted in the regionalization of medical and health care education and patient care on multiple geographically separated campuses. In providing an excellent quality undergraduate, graduate, and continuing health professional education at each site, the health needs of the larger community have been better met and relevant indices of health status demonstrate significant improvement. To continue to provide excellent health care for the people of West Texas, a special effort is made to recruit applicants from West Texas and from rural and border communities. Students from these areas are more likely to service their home regions upon graduation, which ensures the long-term perpetuation of quality health care in West Texas and that the objectives of TTUHSC are continually met.

TTUHSC is a component of the Texas Tech University System. The President of TTUHSC reports to the Chancellor, who is the Chief Executive Officer of the System. The Chancellor and the President are responsible to the TTUS Board of Regents, which sets overall policy for TTUS, Texas Tech University, TTUHSC, TTUHSC El Paso, and Angelo State University. The Provost and Chief Academic Officer reports to the President as Chief Executive Officer of TTUHSC. The following positions of senior academic leadership report to the Provost and Chief Academic Officer: Deans of the School of Medicine, School of Nursing, School of Health Professions, School of Pharmacy, and the Graduate School of Biomedical Sciences. Established in 2019, the Office of the Provost seeks to advance the academic mission of the institution through effective collaboration with all HSC stakeholders. Administrative governance and authority of the School of Medicine is situated in Lubbock, and the Dean is fully responsible for the conduct and maintenance of quality educational experiences and related academic and clinical programs offered by the campuses at Amarillo and the Permian Basin. The Regional Deans of Medicine at Amarillo and Odessa are responsible to the Dean of the School of Nursing and the School of Health Professions utilize the same administrative model. Regional Deans of Health Professions in Amarillo, Odessa and Midland, and the Regional Deans of Nursing in Abilene and Odessa, report directly to their respective Deans in Lubbock. The Dean of Pharmacy is located in Amarillo, with Regional Deans located in Lubbock, Amarillo, Dallas, and Abilene reporting to the Dean in Amarillo. This regional concept allows the schools to establish and operate student education programs, physician residency training programs, continuing education programs, and outreach programs that have proved to be a vital factor in the placement of graduates in practice sites in West Texas, and to support the practice of medicine, nursing, and health professions in this vast area.

TTUHSC is continually striving to make the institution and its programs the most cost effective possible, which has been particularly important as the institution has been growing and developing its programs. In 1985, general revenue made up more than 50% of the total operating budget of TTUHSC. Now, in fiscal year 2021, general revenue is 22.5% of the total budget. Even though TTUHSC has been able to sustain the growth of its schools and programs, adequate levels of state appropriated funds are essential to accomplish the central mission of providing health care education of the highest quality.

TTUHSC is proud of the accomplishments that have been achieved by this institution, some of which are included as follows:

### SCHOOL OF MEDICINE

- Over the past five years, approximately 51% of graduates have remained in Texas to complete residency training, and an average of 20% of School of Medicine graduates have remained in a TTUHSC program for residency training.
- Over 20% percent of the practicing physicians in West Texas are TTUHSC medical school and/or residency graduates.
- Over the past five years, an average of 52% of all medical school graduates have elected to enter the primary care specialties of Family Medicine, Internal Medicine, Obstetrics and Gynecology, and Pediatrics. In 2020, 51% of graduates elected primary care specialties.
- Each of the TTUHSC campuses has been shown to place the majority of its program graduates who stay in West Texas within a 75-mile radius of the campus. The regional campus system has a positive impact on the geographic distribution of physicians throughout West Texas.
- The School of Medicine has combined efforts with Texas Tech University to offer joint academic programs addressing the growing needs of practicing physicians. In the summer of 1998, a venture began with the Rawls College of Business Administration providing the ability to obtain both MD and MBA degrees. A joint JD and MD program to be offered in collaboration with the TTU School of Law began in the fall of 2009 where students interested in future careers focusing on health care policy, bioterrorism, and medical law can receive both degrees.
- The most recent educational program innovation at the School of Medicine is the development of the Family Medicine Accelerated Track (FMAT). As the first program of its kind in the country, FMAT allows students to complete requirements for the medical doctorate in three years, reducing the time and expense of medical school. Graduates enter TTUHSC Family Medicine residency programs, and upon completion are prepared to practice, oftentimes in rural areas of the state.
- In 2016, the School expanded clinical training in Lubbock through a collaborative partnership with Covenant Health Systems. With the support of volunteer faculty, 30 students are assigned to complete Year 3 clerkships at Covenant Medical Center.
- The campuses of the School of Medicine operate 22 individually accredited residency programs and 14 fellowship programs in West Texas. As of October, 2020, these programs had 536 total residents in training, which includes 45 fellows, of which 336 (62.6%) were in primary care fields of Family Practice, Internal Medicine, OB/GYN and Pediatrics. Of the 376 total primary care residents in training, 122 are specifically in Family Practice. The 36 residency and fellowship programs have 162 first year trainees, and will have approximately 165 residents and fellows in 2021.

- The three campuses operate a total of 27 clinical departmental units and numerous clinical services and education programs which were previously unavailable in the West Texas region. A partial list of specialty services includes: care for women and infants, including perinatal care and neonatal intensive care (three campuses), pediatric subspecialty services and intensive care (three campuses), trauma centers and emergency medicine (one campus), neurology and neuroscience centers (one campus), a center for pain treatment and research, a regional burn center, a center for Alzheimer's disease, a cancer center, and a program for bone marrow transplantation.
- The patient care programs of the School of Medicine serve as the base for clinical education of medical students and residents, the base for clinical research and as a major source of care for citizens of West Texas. In fiscal year 2020, the School of Medicine provided 518,615 clinical visits of care and served 194,748 patients. The School also served 41,137 inpatients in its affiliated hospitals. The School provided a total of \$25,915,151 in uncompensated care.

## **GRADUATE SCHOOL OF BIOMEDICAL SCIENCES**

- The Graduate School of Biomedical Sciences (GSBS) became a separate school in 1994 to provide educational training to students who seek research careers in biomedical sciences. The GSBS provides superior graduate education by increasing knowledge and understanding through scholarship and research. The mission of the School is to educate the next generation of scientists and health-related professionals in a dynamic and productive research environment that fosters creativity and discovery. This is accomplished by providing each student with a broad understanding of biomedical research while promoting the specialization needed to succeed as an independent investigator in an environment that highly values diversity of people and ideas.
- The GSBS currently has five graduate programs: Biotechnology (M.S. only), Biomedical Sciences (M.S. and Ph.D.), Graduate Medical Education Sciences (M.S. only), Public Health (M.P.H. only), and Pharmaceutical Sciences (M.S. and Ph.D.). Program/Concentrations by location include:
  - Lubbock: Biochemistry, Cellular & Molecular Biology; Immunology & Infectious Diseases; Molecular Biophysics; Translational Neuroscience & Pharmacology; and three MS only programs: Graduate Medical Education Sciences; Biotechnology and Public Health.

• GSBS stands out in that its tuition/fees and student indebtedness is among the very lowest in the state, in part, by the School paying tuition and fees for all Ph.D. students. The average time to a Ph.D. degree dropped to less than five years, and the number of students matriculating across all programs has substantially increased. Faculty to student ratios remain high, and student publication and presentation rates are rapidly rising. In the past three years, GSBS students have been awarded more fellowships and travel

scholarships than ever before. The Amarillo campus has received considerable accolades for their growth and success, which includes the expansion of the Pharmaceutical Sciences Ph.D. program to Abilene.

- The School has an annual "Diversity Amongst Us" potluck to encourage students to embrace inclusiveness. With a total census of over 200 students, the fall Student Research Retreat was the largest in its history. Every semester, student and faculty engagement and input is openly encouraged at every level of the graduate school.
- The Graduate Student Association hosted the 32nd Annual Student Research Week (SRW) to showcase phenomenal research conducted throughout the area. The theme was "20/20 Visions of Biochemistry". With full participation from all HSC schools, residents and undergraduates from TTU, collaboration was key to the success of the event. The SRW Committee secured two outstanding and highly distinguished keynote speakers, Ernest Marshall Wright, D.SC. and Maralice Conacci-Sorrell, PhD., however, due to the Corona Pandemic, neither speaker was able to travel to Lubbock to participate.
- The Master of Public Health program received accreditation with the Council on Education for Public Health (CEPH) in the summer of 2018. Students have the option to reside on either the Lubbock or Abilene campus, or they can matriculate into the online program.
- In the past 10 years, applications to and enrollment in the Graduate Medical Education Sciences program has increased more than ten-fold. Most GMS graduates are accepted to medical school where they go on to excel, however some graduates choose to continue in education as instructors.

### SCHOOL OF NURSING

The TTUHSC School of Nursing is the only nursing school on the South Plains that provides baccalaureate, masters, and doctoral education. Since its inception in 1979, the school has offered innovative educational programs to meet the needs of Texas residents. With an expanded selection of program options offered throughout Texas and beyond, the School of Nursing continues to help bolster the state's nursing workforce by educating over 2,700 students each year.

The first students were admitted to the Traditional Bachelor of Science in Nursing four-year degree on the Lubbock campus in August, 1981. Four years later, RN to BSN only students were admitted in the Permian Basin. The first students were admitted to the Master of Science in Nursing track in 1988, and the Accelerated Second-Degree track was launched in Austin and in Lubbock in 2005, and is now offered in Abilene, the Permian Basin, Amarillo, Dallas-Ft. Worth area, and San Antonio. In 2008, the inaugural cohort of doctoral students was admitted into the Doctor of Nursing Practice degree program, and in 2009, the Traditional BSN program was expanded to include Abilene and the Permian Basin.

The TTUHSC School of Nursing is known for innovation in nursing education, excellent student retention and graduation rates, above national average National Council Licensure Examination (NCLEX) scores, and producing well-prepared nurses for West Texas and beyond.

**UNDERGRADUATE STUDIES**: The School of Nursing offers three programs to obtain the Bachelor of Science in Nursing degree:

- Traditional BSN Track
- RN to BSN Track (for individuals who already hold a license as a Registered Nurse)
- Accelerated BSN Program
  - Second Degree BSN Track \* (for individuals with a bachelor's degree in another field)
  - Veteran to BSN Track \* (for veterans and active duty military personnel with a healthcare specialist rating)

\* The Second-Degree BSN and Veteran to BSN tracks comprise the Accelerated BSN Program, and students enrolled in these tracks complete the same curriculum. Admission criteria differ, and Veteran to BSN students have the opportunity to complete Comprehensive Assessment Placement exams based on prior military/medical experience.

**GRADUATE PROGRAMS**: The Graduate Departments use a variety of online technology teaching-learning methods to offer distance education classes and face-to-face classes in Lubbock, Odessa and Abilene. The school offers these graduate degrees and certificates:

#### **Center of Excellence in Evidence-Based Practice:**

A Center of Excellence in Evidence-Based Practice (CEEBP) has been established at the School of Nursing. The CEEBP forms collaborations to improve the care and safety of patients through consultation, research, education, and practice as demonstrated through multiple avenues. The Center is multidisciplinary and/or interdisciplinary groups of faculty and their associates who have been brought together for the pursuit of research, education, and/or clinical activities. The goals of this Center integrate into the strategic plan of the School of Nursing.

## SCHOOL OF HEALTH PROFESSIONS

• The School of Health Professions offers 21 different doctoral, masters, baccalaureate, post baccalaureate degree programs and 7 certificate programs in health professions. With a Fall 2020 enrollment of 1,971 students on four campuses (Lubbock, Amarillo, Odessa and Midland) and online, it is one of the largest and most diverse schools of Health Professions in Texas. From our first class of 18 students in 1983, the School has grown steadily over the past 37 years. The mission of the School of Health Professions is to enhance the quality of life of those we serve by delivering exemplary holistic student-centered education and cultivating research opportunities, while championing interprofessional and clinical care partnerships that are innovative and relevant to the communities we serve.

- To increase educational access to health professionals who are serving communities throughout rural West Texas and the state, some programs rely extensively on non-traditional formats or distance education technologies.
  - The ScD-PT employs a unique combination of weekend clinical clusters in communities around the state and nation that are supported by distance education technology, as well as short, intensive periods on campus to offer practicing physical therapists the opportunity to achieve advanced clinical skills and competencies while maintaining their practice.

- The Post-Professional Doctor of Occupational Therapy (OTD) online program is an exciting new health care degree offered by the School of Health Professions. This recently launched online degree program is designed for licensed occupational therapists who have earned a bachelor's or master's degree in occupational therapy and want to elevate their professional occupational therapy degree to the doctoral level. The online post-professional OTD program provides licensed occupational therapists with the advanced knowledge and practice skills needed to elevate their professional competencies, advance their careers, and position them for leadership roles within the health care environment and in the occupational therapy profession.
- The M.S. in Healthcare Administration provides an online opportunity for traditional clinicians and other health professionals to expand their knowledge and skills in healthcare administration without leaving their communities.
- The M.S. in Clinical Rehabilitation Counseling, M.S. in Clinical Mental Health Counseling and M.S. in Addiction Counseling programs provide students with the skills necessary to become successful professional counselors. Additionally, students are trained in telehealth techniques during their clinical practicums, preparing them for distanceservice provision.
- The Bachelor of Science in Clinical Laboratory Science program offers a second-degree online tract for students who already hold a Bachelor of Science degree. A second online tract is available for students who wish to earn a certificate in clinical laboratory science. Both online tracts qualify students to sit for the national certification in clinical laboratory science through the American Society of Clinical Pathology Board of Certification.
- The Bachelor of Science in Healthcare Management program provides a web-based baccalaureate degree for traditional undergraduate students and graduates of community college Associate of Applied Science programs to prepare for career ladder progression, while continuing employment within their communities.
- In addition to its 21 different degree programs, the School operates two Centers that have been approved by the Texas Tech University System Board of Regents:
  - The **Center for Speech, Language and Hearing Research** within the Department of Speech, Language and Hearing Sciences seeks to integrate and support cross-disciplinary efforts in research, teaching and patient care that are aimed at increasing understanding and treatment of hearing, speech and/or language disorders across the lifespan.
  - The **Center for Rehabilitation Research** within the Department of Rehabilitation Sciences is an internationally renowned research, education and clinical assessment center that serves TTUHSC and the region. The Center is dedicated to improving the lives of people who have functional limitations caused by physical impairments. The Center consists of six core faculty members, associate faculty, and four clinical research laboratories, including the Clinical Anatomy Research Laboratory, Clinical Biomechanics (Gait) Research Laboratory, Clinical Musculoskeletal Research Laboratory, and the Clinical Postural Control Research Laboratory. The Center provides a rich research environment for the PhD in Rehabilitation Science program.
- The School has an active faculty development program to encourage and provide financial support for faculty who participate in doctoral studies to strengthen the knowledge, skills and abilities of our faculty.

## SCHOOL OF PHARMACY

- The TTUHSC School of Pharmacy (SOP) was established in 1993 as a four-year Doctor of Pharmacy (Pharm.D.) program, one of a very small number of publicly funded pharmacy schools to be created at that time in the United States in over 40 years. It has its home base in Amarillo, the only fully accredited School in TTUHSC to have its home base outside of Lubbock. The School enrolled its first Pharm.D. class of students in the Fall of 1996, with the founding class graduating in May 2000. In 1999, the Dallas and Lubbock campuses were opened as two-year Regional campuses hosting 3<sup>rd</sup> and 4<sup>th</sup> year students. In the Fall of 2007, the School expanded its 4-year Pharm.D. program to Abilene. In 2018, the Dallas campus was expanded from 2 to 4 years to offer the full complement of the Pharm.D. education to the Dallas/Fort Worth metroplex, creating the 3<sup>rd</sup> 4-year Pharm.D. campus for the School. A year later, the University acquired ownership of building and property in the Dallas medical center immediately adjacent to the UTSW Medical School.
- In 2019, the TTUHSC School of Pharmacy was named to honor Amarillo pharmacist, businessman, and philanthropist, Jerry H. Hodge. The naming was approved by the Texas Tech University System Board of Regents, and it honors Mr. Hodge's lifelong dedication and support to TTUHSC. Mr. Hodge's leadership and initiative at the state and local level were instrumental in helping the university establish the School of Pharmacy in 1993.
- In addition to the traditional Pharm.D. Program, the School also supports:
  - a graduate Ph.D./M.S. Program in Pharmaceutical Sciences and a graduate M.S. Program in Biotechnology in collaboration with the Graduate School of Biomedical Sciences to train pharmacists and scientists in medicinal chemistry, pharmaceutics, pharmacology, biotechnology and drug development;
  - > a joint Pharm.D./M.B.A. program in conjunction with the TTU Rawls College of Business; and
  - a Pharmacy Residency Program in advanced pharmacy education. Through the Residency Program, pharmacists gain higher level practice skills leading to specialization beyond the basic Pharm.D. professional degree.
- Over the course of its history, the School has conferred 2,230 Pharm.D. degrees and 109 have graduated with a joint Pharm.D./MBA degree. In addition, 413 residents have completed the Pharmacy Residency program. In the Pharmaceutical Sciences program, a total of 107 doctoral Ph.D. degrees have been awarded, as well as 11 Master of Sciences degrees.
- The School's vision statement focuses on the pharmacist in the modern healthcare team. The School is learner-centered, collegial, interprofessional, and cutting edge in pharmacy, dedicated to the highest standards of care for patients.
- The first class of Pharm.D./M.B.A. students began coursework in the Summer of 2009. The Health Organization Management program at Rawls College of Business is one of the strongest accredited programs in the nation.

- The School is committed to providing West Texas and the Dallas/Fort Worth Metroplex with innovative pharmaceutical care. The faculty and pharmacy residents provide patient care through various contracts with external healthcare institutions including hospitals, community pharmacies, nursing homes, clinics, and the Texas Department of Criminal Justice.
- The School manages two pharmacies as teaching models of modern pharmaceutical care. These pharmacies include:
  - > Amarillo Amarillo Pharmaceutical Care Center
  - Lubbock TTUHSC Pharmacy (main campus)
- The School hosts the Texas Panhandle Poison Center (TPPC), which serves 71 counties that cover the Amarillo, Lubbock, Wichita Falls and Abilene health marketing areas. For FY 2020, the TPPC handled 17,637 calls on poisons and related issues. Further, the School hosted Medication Cleanout events which took in 2,698 pounds of unwanted medications and 347 pounds of used sharps during FY 2020 in Amarillo, Abilene, Pampa and Lubbock that might otherwise have been disposed of improperly.
- In addition to its direct patient care initiatives, the School supports a significant research program with >25,000 sq. ft. of dedicated laboratory research space with over **\$6.1** million in annual external research grant funding. Research expenditures by the School exceeded **\$8.6** million during the same period from all sources. In September 2020, the school received a major \$2.8 M grant to fund a new super high-resolution confocal microscope in Amarillo, Texas. This grant was awarded by the Cancer Prevention and Research Institute of Texas (CPRIT). Other major sources for school research funding include the National Institutes of Health (NIH) and the Department of Defense (DOD). Faculty, students and postdoctoral graduates together published over 100 research and scholarly publications in FY2020. Primary areas of progress included patient care and drug treatment, cancer and cardiovascular research, drug delivery, drug discovery and development, and primary mechanisms of disease development and progression.
- Each year the School convenes a research retreat named Research Days to bring together faculty, residents, staff and students to discuss research progress over the previous year and to foster future collaborations on new projects and initiatives. The event is held annually in June. In 2020, this event was canceled due to the COVID-19 pandemic. Instead, the School focused on efforts to slow progression and spread of the virus and supported testing and other public health efforts. A primary initiative of the Departments of Pharmacy Practice and Pharmaceutical Sciences was in production of sterile Vital Transport Media (VTM) to support nucleic acid tests for the virus across Texas. The VTM effort was a joint effort of the School of Pharmacy with the School of Medicine. By September 2020, greater than 350,000 VTM vials had been produced with the ongoing average production rate at approximately 3700 vials per week.

## **INSTITUTES**

TTUHSC is home to five Institutes: the F. Marie Hall Institute for Rural and Community Health, the Laura W. Bush Institute for Women's Health, the Garrison Institute on Aging, the Clinical Research Institute, and the Institute of Anatomical Sciences.

#### F. Marie Hall Institute for Rural and Community Health:

The goal of the F. Marie Hall Institute for Rural and Community Health is to collaborate with various stakeholders to study rural health issues, to identify or formulate innovative rural health solutions, and to contribute to the scientific basis for programs and projects that lead to improved health care access, better health outcomes, and sustainable best practices. Some examples of how the RCH has transformed health care include the Telemedicine Wellness Intervention Triage and Referral (TWITR) Project, a first of its kind demonstration project to bring mental health services to rural school districts with limited mental health resources to serve students with behavioral or mental health disorders, as well as providing training and support to teachers, school counselors and administrative staff. This has been adopted statewide by the Texas Consortium for Child Mental Health and funded by the legislature. Another innovation is the Campus Alliance for Telehealth Resources (CATR), an ECHO model, to create sustainable learning communities to equip school counselors and others to identify and properly manage mental health issues among school children funded by the legislature as a new demonstration project. The Next Gen 911 Project is an innovation and proof of concept that telemedicine can be used to triage and treat patients from EMS trucks in route to the most appropriate treatment facility, heavily used during the CoViD pandemic. In addition to these examples, the RCH houses the TexLa Telehealth Resource Center, one of only 14 in the national telehealth network funded by HRSA; the West Texas Area Health Education Center (AHEC), with six regional centers serving all of West Texas; the Research, Reporting, and Data Management Division that produces the *Rural Health Quarterly* magazine; and other award-winning research. In educational innovations, the RCH operates the Frontiers in Telemedicine (FiT) lab, which is a one-of-a-kind facility that provides competency-based education for a wide variety of health care providers and students specific to telemedicine presenting procedures, technology, and coding, billing and business-related practices. The RCH is an innovation and collaboration hub that works daily where the staff focus imagination, talents, and energy to improve the health and well-being of the people and communities of West Texas and beyond.

#### Laura W. Bush Institute for Women's Health:

In 2000, the Women's Health Research Institute was initiated by TTUHSC in Amarillo as a community-wide effort to improve women's health through research, education and outreach. In 2007, First Lady Laura W. Bush approved the use of her name for the Institute, providing a powerful endorsement for the mission of the Laura W. Bush Institute for Women's Health. In 2008, the Institute expanded to include TTUHSC campuses in Lubbock, Amarillo, El Paso, and the Permian Basin, and in later years, San Angelo, Abilene and Dallas. The LWB Institute for Women's Health is dedicated to improving the lives of women and girls in Texas and across the nation by advancing multidisciplinary science in women's health. Recognizing that sex and gender differences matter, we promote health, individually inspired, through scientific investigation, translation of science into practice, and providing outreach that impacts the community well into the future.

#### Garrison Institute on Aging:

The Garrison Institute on Aging (GIA) is the keystone of the TTUHSC initiative to help older adults successfully extend and improve quality of life. From investigating the causes of neurodegenerative diseases - like Alzheimer's, Parkinson's, Huntington's Disease and Multiple Sclerosis - to educating seniors on preventive medicine and challenges impacting the geriatric population, the GIA seeks to generate and disseminate knowledge about neurodegenerative disorders and about aging and aging-related health issues. Using cutting edge research methods and state-of-the-art techniques, scientists at the Institute are actively working to identify novel targets and develop and test promising new drug compounds to improve healthy aging, and to prevent and/or stop the progression of neurodegenerative and other aging-related diseases. In addition to research facilities for behavioral studies, electrophysiology and molecular biology, the Institute houses biobanks for human brain tissue, bodily fluids, and DNA for GIA-based research as well as collaborations engaging faculty and trainees across TTUHSC. A <u>Collaborative Seed Grant Program in Aging</u> was established, led by basic scientists, clinicians, public health, and community outreach specialists that are based in nine departments across four TTUHSC schools. These projects are expected to yield preliminary data for grant proposals. Another key program, <u>Project FRONTIER</u>, initiated in 2006, continues to investigate cognitive decline and associated risk factors longitudinally among a multi-ethnic sample of adults in rural West Texas. Educational and outreach programs include the Translational Research Seminar Series, Healthy Aging Lecture Series, Care Partner Academy, Retired and Senior Volunteer Program, Healthy Lubbock, and National Alzheimer's Awareness Month activities.

#### Clinical Research Institute:

The Clinical Research Institute (CRI) provides training and facilitates clinical research by faculty, fellows, residents and students from each school on each campus. Investigator-initiated clinical research is emphasized as a scholarly activity, meeting requirements such as residency and Health Sciences schools certification. The CRI currently assists in study design, preparation of documents to submit to the Institutional Review Board, conduct of the study, statistical evaluation of data and writing of presentations and manuscripts for over 200 studies currently. The number of new studies, investigators and publications increases each year, reflecting the growth of the Institute's activities.

#### Institute of Anatomical Sciences:

The Institute of Anatomical Sciences (Anatomy Institute) was established in 2019 and promotes interdisciplinary anatomical education, research, and outreach missions of all schools within TTUHSC. The Institute exists to create innovative and collaborative methods of improving healthcare delivery and effectiveness through greater knowledge and understanding of clinical anatomy. The Anatomy Institute houses the long-standing Willed Body Program (established in 1972) and aims to be an integral part of TTUHSC education of faculty and trainees. The Institute occupies the entire first floor (~20,000 square feet) of the newly constructed facility, and has space designated for anatomical dissection, education, research, surgical simulation, and the Willed Body Program. In the two months (July-August) that the Institute was open in FY2020, a total of 430 students used the onsite dissection space (218 SOM/GMS students and 212 SHP students - MPA, MAT, DPT, OTD, PhD). Sixty-Three potential students benefited from the Institute's technology as part of the JAMP and PEP programs through the SOM Office of Admissions. One international broadcast course was conducted using the Institute's resources. The Institute is equipped with state-of-the-art learning spaces that support multiple modes of clinical anatomy research including investigator-initiated research, research supported by grants from outside sources, and carefully selected industry-sponsored studies.

## MANAGED CARE (MC)

During the 1993 Legislative session, the Texas Legislature established a Correctional Managed Health Care Advisory Committee (CMHCAC) and charged it with developing a managed health care delivery system to provide health care to Texas Department of Criminal Justice (TDCJ) offender patients. The Committee, and eventually the TDCJ, established a contract with TTUHSC to provide health care for the TDCJ facilities in the western part of the state. This region spans over 100,000 square miles; from El Paso to Dalhart to Brownwood. Of the approximately 146,000 offenders housed in TDCJ facilities statewide, TTUHSC MC is responsible for the healthcare of approximately 29,000 offender patients, in 23 facilities at 18 sites.

Each state has a responsibility to meet constitutional obligations, protect public safety, and practice fiscal prudence when providing healthcare to the correctional population. This is often referred to as the Triple Aim of correctional healthcare: increased access, increased safety, and decreased cost. Each state strives to meet the Triple Aim at varying cost and varying success. Over the last thirty years, Texas has demonstrated that its public Health Related Institutions are well positioned to meet this population's unique healthcare needs. Namely, the correctional population as a whole is aging and patients with advanced age typically require more healthcare resources. The correctional population is also more likely to need behavioral health services. Today, almost 40% of offender patients have a mental health diagnosis and 12.5% require psychotropic medication management.

Despite these challenges, Managed Care continues to be a wise investment for Texas. The Texas Legislature recently commissioned a study to compare costs between Medicaid, TRS, ERS, and care provided through TDCJ. This study found that healthcare provided through the TDCJ contract had the lowest per capita cost and an overall annual increase below 5%. Furthermore, the cost of correctional healthcare in Texas is low compared to other states. In a recent report from The Pew Charitable Trusts, Texas reported lower per-capita spending than 35 other states. At the same time, TTUHSC Managed Care tracks and reports healthcare outcomes utilizing the National Committee for Quality Assurance (NCQA) Healthcare Effectiveness Data & Information Set (HEDIS) measures. Therefore, our health outcomes can be compared to care provided in any other setting. The high level of healthcare provided by TTUHSC Managed Care is also represented by the successful national accreditation of all facilities by the American Correctional Association.

The scope of healthcare services provided by Managed Care is broad and inclusive of various types of facilities. In January 1996, TTUHSC began providing behavioral health care in West Texas. These services continue at the John Montford Unit, a 550-bed psychiatric inpatient facility located in Lubbock. In addition, TTUHSC operates two special behavioral health programs at the Bill Clements Unit in Amarillo; the state's only Program for the Aggressively Mentally III Offenders (PAMIO), as well as, a Chronic Mentally III (CMI) Treatment Program, with a Sheltered Housing component. The PAMIO program has received national recognition for the innovative approaches to these challenging patients.

Managed Care also provides quality inpatient medical care to our offender patient population. In September 1996, the Western Regional Medical Facility (RMF), with a 50-bed ward, 4-bed special care unit, and 30 holding beds, opened adjacent to the psychiatric inpatient facility. The RMF includes two surgical suites and is equipped to provide endoscopy, chemotherapy, dialysis, and physical therapy. In July 2006, a 44-

bed long term care unit was added, yielding a total of 128 medical/surgical and emergent care beds. These inpatient beds are fully utilized and provide collaborative opportunities among Managed Care and other TTUHSC departments and community providers.


In an effort to achieve the "Triple Aim" of correctional healthcare, TTUHSC MC has expanded telehealth capabilities to 100% of its TDCJ facilities. Primary care, specialty care, and behavioral healthcare can all be provided through the telehealth modality. The utilization of telehealth services provides expanded access to these healthcare disciplines without compromising quality care. HEDIS outcomes are comparable between telehealth patients and face-to-face visits. The Managed Care telehealth program also enables providers to see patients at multiple units each day without burdensome travel time and cost. Additionally, the use of telehealth reduces the need to transport patients offsite for specialty services. The Managed Care Tele-Optometry program alone eliminates the need for hundreds of transports each year. This reduction in transport enhances the safety of patients, staff, and the public, while decreasing related costs for the TDCJ. In 2020, Managed Care achieved accreditation by URAC, the nation's largest and most experienced telehealth accreditor. TTUHSC is the first Health Sciences Center in the state of Texas to achieve this distinction.

In 2019, Managed Care began engaging in new partnerships to provide health care services to additional populations. Managed Care now provides telehealth and behavioral health services within several county jails, Immigration and Customs Enforcement facilities, and Federal Bureau of Prisons facilities in Texas and New Mexico. These new service areas allow Managed Care to expand the reach of its quality healthcare services while generating revenue to support the university.


Managed Care plays an important role in TTUHSC's educational mission. Working in the correctional setting is a valuable clinical experience with a population that has unique healthcare needs. In addition to the School of Medicine, Managed Care has provided training for students in the Advanced Practice Provider, Pharmacy, Audiology, Lab Science, and Clinical Therapy programs. All Managed Care Pharmacy services are provided in coordination with the TTUHSC School of Pharmacy in Amarillo. By integrating correctional healthcare into our curriculum, students and residents are exposed to a practice setting they may not have previously considered.

TTUHSC Managed Care has positively impacted patient lives for three decades, including many who previously never had access to quality health care, and welcomes the opportunity to continue to do so.












TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER Executive Vice President for Finance & Operations Organizational Chart November, 2020





















#### TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER Institutional Compliance Organizational Chart November, 2020




TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER School of Medicine Organizational Chart November, 2020




TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER Graduate School of Biomedical Sciences Organizational Chart November, 2020






TEXAS TECH UNIVERSITY HEALTH SCIENCES CENTER School of Nursing Organizational Chart November, 2020






# TTUHSC Enrollment Trends Fall 2011 - Fall 2020






# TTUHSC Degrees Awarded by Academic Year 2011 - 2020








# Financial Aid Dollars Awarded to Students 2011-12 through 2020-21 est.




